

## Student Right-to-Know

Title I, Section 103 of The "Student Right-to-Know and Campus Security Act" (P.L. 101-542) requires institutions eligible for Title IV funding to calculate graduation rates of certificate- or degree-seeking, first-time, full-time students entering that institution, and to disclose these rates to all students and prospective students.

### Graduation Rate

The graduation rates listed below are based upon a limited cohort of full-time, first-time students who initiated their program of study between 09/01/2014 and 08/31/2015.

Air Conditioning, Refrigeration, and Heating

Orleans Technical College is accredited by the Accrediting Commission of Career Schools and Colleges (ACCSC). This document allows Orleans Tech to comply with Section IV (C)(3), Substantive Standards, Standards of Accreditation, regarding the disclosure of student achievement rates.

**The graduation rate for the 6-month Air Conditioning, Refrigeration, and Heating program as reported to the Accrediting Commission of Career Schools and Colleges (ACCSC) is 87%. Orleans Tech reported this rate as part of its 2017 annual report to ACCSC. The rate is based on 61 students who began their training between 07/01/2015 and 06/30/2016.**

**The graduate employment rate for the 6-month Air Conditioning, Refrigeration, and Heating program as reported to the Accrediting Commission of Career Schools and Colleges (ACCSC) is 67%. Orleans Tech reported this rate as part of its 2017 annual report to ACCSC. The rate is based on 53 graduates who began their training between 07/01/2015 and 06/30/2016.**

**The graduation rate for the 13-month Air Conditioning, Refrigeration, and Heating program as reported to the Accrediting Commission of Career Schools and Colleges (ACCSC) is 73%. Orleans Tech reported this rate as part of its 2017 annual report to ACCSC. The rate is based on 22 students who began their training between 09/01/2014 and 08/31/2015.**

**The graduate employment rate for the 13-month Air Conditioning, Refrigeration, and Heating program as reported to the Accrediting Commission of Career Schools and Colleges (ACCSC) is 69%. Orleans Tech reported this rate as part of its 2017 annual report to ACCSC. The rate is based on 16 graduates who began their training between 09/01/2014 and 08/31/2015.**
