

Student Right-to-Know

Title I, Section 103 of The "Student Right-to-Know and Campus Security Act" (P.L. 101-542) requires institutions eligible for Title IV funding to calculate graduation rates of certificate- or degree-seeking, first-time, full-time students entering that institution, and to disclose these rates to all students and prospective students.

Building Maintenance

The graduation rate for the 6-month Building Maintenance program as reported to the Accrediting Commission of Career Schools and Colleges (ACCSC) is 86%. Orleans Tech reported this rate as part of its 2019 annual report to ACCSC. The rate is based on 60 students who began their training between 07/01/2017 and 06/30/2018.

The graduate employment rate for the 6-month Building Maintenance program as reported to the Accrediting Commission of Career Schools and Colleges (ACCSC) is 65%. Orleans Tech reported this rate as part of its 2019 annual report to ACCSC. The rate is based on 51 graduates who began their training between 07/01/2017 and 06/30/2018.

The graduation rate for the 13-month Building Maintenance program as reported to the Accrediting Commission of Career Schools and Colleges (ACCSC) is 83%. Orleans Tech reported this rate as part of its 2019 annual report to ACCSC. The rate is based on 12 students who began their training between 09/01/2016 and 08/31/2017.

The graduate employment rate for the 13-month Building Maintenance program as reported to the Accrediting Commission of Career Schools and Colleges (ACCSC) is 80%. Orleans Tech reported this rate as part of its 2019 annual report to ACCSC. The rate is based on 10 graduates who began their training between 09/01/2016 and 08/31/2017.
