

## Student Right-to-Know

Title I, Section 103 of The "Student Right-to-Know and Campus Security Act" (P.L. 101-542) requires institutions eligible for Title IV funding to calculate graduation rates of certificate- or degree-seeking, first-time, full-time students entering that institution, and to disclose these rates to all students and prospective students.

### Graduation Rate

The graduation rates listed below are based upon a limited cohort of full-time, first-time students who initiated their program of study between 09/01/2016 and 08/31/2017.

## Achievement Rates

Plumbing and Heating

Orleans Technical College is accredited by the Accrediting Commission of Career Schools and Colleges (ACCSC). This document allows Orleans Tech to comply with Section IV (C)(3), Substantive Standards, Standards of Accreditation, regarding the disclosure of student achievement rates.

**The graduation rate for the 6-month Plumbing and Heating program as reported to the Accrediting Commission of Career Schools and Colleges (ACCSC) is 84%. Orleans Tech reported this rate as part of its 2019 annual report to ACCSC. The rate is based on 19 students who began their training between 07/01/2017 and 06/30/2018.**

**The graduate employment rate for the 6-month Plumbing and Heating program as reported to the Accrediting Commission of Career Schools and Colleges (ACCSC) is 88%. Orleans Tech reported this rate as part of its 2019 annual report to ACCSC. The rate is based on 16 graduates who began their training between 07/01/2017 and 06/30/2018.**

**There were no students who enrolled in the 13-month Plumbing and Heating program between 9/1/2016 and 8/31/2017; therefore, Orleans Technical College did not submit graduation or graduate placement data to ACCSC as part of its 2019 report to ACCSC.**
