The Commonwealth of Pennsylvania did not allow in-person instruction at the height of our stay-at-home orders, and the City of Philadelphia prohibited in-person instruction for a slightly longer period of time. We are a career & technical college (skilled trades) with a heavy emphasis of hands-on learning. We could not pivot to virtual or hybrid learning during this hiatus. During our stay-at-home orders that extended from 3/16/2020 through 7/5/2020, we did not teach any students and we did not
