The graduate employment rate for the 6-month Building Maintenance program as reported to the Accrediting Commission of Career Schools and Colleges (ACCSC) is 73%. Orleans Tech reported this rate as part of its 2023 annual report to ACCSC. The rate is based on 36 graduates who began their training between 07/01/2021 and 06/30/2022.
