

## Student Right-to-Know

Title I, Section 103 of The "Student Right-to-Know and Campus Security Act" (P.L. 101-542) requires institutions eligible for Title IV funding to calculate graduation rates of certificate- or degree-seeking, first-time, full-time students entering that institution, and to disclose these rates to all students and prospective students.

### Graduation Rate

The graduation rates listed below are based upon a limited cohort of full-time, first-time students who initiated their program of study between 09/01/2019 and 08/31/2020.

## Achievement Rates

### Residential and Commercial Electricity

Orleans Technical College is accredited by the Accrediting Commission of Career Schools and Colleges (ACCSC). This document allows Orleans Tech to comply with Section IV (C)(3), Substantive Standards, Standards of Accreditation, regarding the disclosure of student achievement rates.

**The graduation rate for the 6-month Residential and Commercial Electricity program as reported to the Accrediting Commission of Career Schools and Colleges (ACCSC) is 89%. Orleans Tech reported this rate as part of its 2023 annual report to ACCSC. The rate is based on 79 students who began their training between 07/01/2021 and 06/30/2022.**

**The graduate employment rate for the 6-month Residential and Commercial Electricity program as reported to the Accrediting Commission of Career Schools and Colleges (ACCSC) is 74%. Orleans Tech reported this rate as part of its 2023 annual report to ACCSC. The rate is based on 70 graduates who began their training between 07/01/2021 and 06/30/2022.**

**There were no students who began training in the 8-month Residential and Commercial Electricity program between 07/01/2021 and 06/30/2022; therefore, Orleans Technical College did not submit graduation or graduate employment data to ACCSC as part of its 2023 annual report to ACCSC.**

**The graduation rate for the 13-month Residential and Commercial Electricity program as reported to the Accrediting Commission of Career Schools and Colleges (ACCSC) is 100%. Orleans Tech reported this rate as part of its 2023 annual report to ACCSC. The rate is based on 1 student who began training between 09/01/2020 and 08/31/2021.**

**The graduate employment rate for the 13-month Residential and Commercial Electricity program as reported to the Accrediting Commission of Career Schools and Colleges (ACCSC) is 100%. Orleans Tech reported this rate as part of its 2023 annual report to ACCSC. The rate is based on 1 graduate who began training between 09/01/2020 and 08/31/2021.**

**There were no students who began training in the 14-month Residential and Commercial Electricity program between 07/01/2020 and 06/30/2021; therefore, Orleans Technical College did not submit graduation or graduate employment data to ACCSC as part of its 2023 annual report to ACCSC.**
