Residential and Commercial Electricity

The graduation rate for the <u>6-month</u> Residential and Commercial Electricity program as reported to the Accrediting Commission of Career Schools and Colleges (ACCSC) is 87%. Orleans Tech reported this rate as part of its 2024 annual report to ACCSC. The rate is based on 92 students who began their training between 07/01/2022 and 06/30/2023.

The graduate employment rate for the <u>6-month</u> Residential and Commercial Electricity program as reported to the Accrediting Commission of Career Schools and Colleges (ACCSC) is 75%. Orleans Tech reported this rate as part of its 2024 annual report to ACCSC. The rate is based on 80 graduates who began their training between 07/01/2022 and 06/30/2023.

There were no students who began training in the <u>8-month</u> Residential and Commercial Electricity program between 07/01/2022 and 06/30/2023.; therefore, Orleans Technical College did not submit graduation or graduate employment data to ACCSC as part of its 2023 annual report to ACCSC.

The graduation rate for the <u>13-month</u> Residential and Commercial Electricity program as reported to the Accrediting Commission of Career Schools and Colleges (ACCSC) is 67%. Orleans Tech reported this rate as part of its 2024 annual report to ACCSC. The rate is based on 18 students who began training between 09/01/2021 and 08/31/2022.

The graduate employment rate for the <u>13-month</u> Residential and Commercial Electricity program as reported to the Accrediting Commission of Career Schools and Colleges (ACCSC) is 75%. Orleans Tech reported this rate as part of its 2024 annual report to ACCSC. The rate is based on 12 graduates who began training between 09/01/2021 and 08/31/2022.

There were no students who began training in the <u>14-month</u> Residential and Commercial Electricity program between 07/01/2021 and 06/30/2022; therefore, Orleans Technical College did not submit graduation or graduate employment data to ACCSC as part of its 2024 annual report to ACCSC.
